

About the Museum:

Situated in a historic building in downtown Charleston, South Carolina, the Children's Museum of the Lowcountry features seven indoor exhibit rooms and an outdoor play area, all designed using expert knowledge of how young children learn through self-directed play. The museum develops educational programs and activities specifically tailored to the developmental needs of children from birth to age 8, with a focus on supporting both cognitive and social-emotional growth.

For more than 20 years, the museum has been a regional leader in creating engaging exhibits and innovative early childhood programs that foster curiosity, creativity, and problem-solving. In addition to serving young children, the museum also supports caregivers recognizing parents as a child's first and most important teacher and provides educators with tools to enhance learning both inside and outside the classroom.

To reach as many children and families as possible across South Carolina's diverse Lowcountry region, the museum actively works to remove barriers to access. These efforts include:

- > Offering all summer camp seats at no cost at the museum's satellite location in St. George;
- > Hosting twice-monthly private sessions with free admission for families with children with special needs;
- > Providing two Less-Than-a-Dollar Saturdays annually, one in spring and one in fall;
- > Participating in the Museums for All program at both locations, through which families receiving SNAP or WIC benefits pay only \$3 per person up to \$12 off regular admission resulting in nearly \$90,000 in savings to families annually; and
- > Bringing hands-on STEAM-based learning directly to schools and community events through its Mobile Museum experience, supported through grant funding.

Programs:

In addition to its interactive exhibits, the Children's Museum of the Lowcountry offers a robust calendar of programming that enhances the visitor experience and deepens learning through hands-on, developmentally appropriate activities. These programs are designed to engage children from birth through age 8 and support their cognitive, social, and emotional development.

The museum hosts a variety of regular offerings, including:

- > Standards-based field trips aligned with South Carolina Department of Education curriculum standards;
- > Art programs that explore various media and techniques, from drawing and crafting to textile arts;
